Following the entry into force of 25 May 2018, REGULATION OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL (EU) 2016/679 of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and the repeal of Directive 95 / 46 / WE (General Data Protection Regulation or RODO) we want to give you some information: First of all, we care about your privacy, security of your personal data, as well as we wish to provide you with the possibility to fulfil all your laws in connection with GDPR. We also wish to provide you with the best-suited marketing contents

The Controller (Administrator) of your personal data is the company Zakłady Metalowe w Przysiekach Sp. z o.o. with its registered office in Przysieki 421, 38-207 Przysieki. Your personal data are processed exclusively for the purpose of sending marketing offers and quotations, replying to your enquiries, or other matters for which you contact us. The legal basis for processing your personal data are legitimate interests of the company Zakłady Metalowe w Przysiekach Sp. z o.o., which include proper customer service, replying to your questions or opinions which we receive (i.e. Art. 6 (1) letter f) of the General Data Protection Regulation of 27th April 2016, hereinafter referred to as the "GDPR"). Your data will be transmitted exclusively to entities providing support services to our company (e.g. transport companies, logistics companies, cargo forwarders, or drivers providing delivery solutions, customs agencies etc.). Please be informed that transmitting your personal data will only take place in case when a customer will ask for such a home delivery of goods solution and will express free-will consent of disclosing his or her personal details, including his or her delivery address. In case when a customer decides to pick up goods from our company himself or herself (EXW Incoterms), his or her personal data will not be transmitted to any third parties. Apart from aforementioned entities, your personal data can be disclosed only on request of entities authorised to receive those data on the basis of law. Your personal data will be used by us only for the period necessary to provide reply, business cooperation, business contracts, issuing sales invoices, e-marketing etc. or until you decide to cancel your consent for your personal data processing. Provision of personal data is voluntary, however, failure of their provision will result in lack of the possibility of providing answer by us. You have the right of access to your personal data, their rectification, deletion, limiting their processing as well as data portability right. You also have the right to object to processing your personal data.
